



Offer Terms and Conditions

- The “Offer” is open to only select American Express® Cardmembers whose accounts are valid and in good standing. An American Express Cardmember for the purpose of this Offer means a person holding an American Express® Platinum ReserveSM Credit Card, American Express® Platinum Travel Credit Card, American Express® Gold Card, American Express Membership Rewards® Credit Card or Everyday Spend American Express® Gold Credit Card issued by American Express Banking Corp. in India.
- The Offer is **not** valid for American Express Cards except the Cards mentioned above.
- The Offer is **not** valid for American Express Corporate Cards issued by American Express Banking Corp. in India or Cards issued by a third party bearing the name or trademark or service mark or logo of American Express (“Network Cards”) issued in India.

Paytm Movie Vouchers Terms and Conditions

- Vouchers will be in the form of Paytm couple movie e-vouchers.
- Vouchers can be redeemed ONLY on Paytm mobile app or website for booking of movie tickets and cannot be redeemed directly at the cinema/venue box office.
- Vouchers will be valid for 45 days after date of delivery of the vouchers.
- Vouchers can be used only once within the validity period. A user cannot redeem the remaining Voucher value in subsequent transactions if he/she did not utilize the entire ₹1,000 on the first booking using the Vouchers.
- Each Voucher can be redeemed for only 2 free movie tickets worth up to ₹1,000 (inclusive of convenience fee and applicable taxes). Vouchers cannot be redeemed for bookings in which the booking amount, including convenience fee and applicable taxes, is greater than ₹1,000.
- Vouchers will be valid only for Paytm’s partner cinemas in India. Vouchers will not be applicable on cinemas which accept advance tokens only (with ticket price to be paid at the counter).
- If lost/misused, the vouchers cannot be replaced or revalidated.
- Vouchers cannot be exchanged for point(s) or cash & cannot be re-validated once past expiry date.
